District Councillor Report - 11/2/2015

Broadband

Despite a request from Bernard Jenkin MP for BDUK Superfast Essex to meet me, which was sent to them well before Christmas, they have failed to arrange the meeting.

Following communications with TDC, BDUK Superfast Essex confirmed to me via TDC that they have no plans to upgrade cabinet 4 in Little Oakley. BDUK have indicated that cabinet customers will receive at least 2 Mb/s by summer 2016 due to "general network improvements".

I have also been in discussions with BT regarding the rollout of broadband in both Great and Little Oakley. BT indicated that their commercial programme has now finished and they therefore have no planned upgrades to solve the issues that I raised. They also confirmed that cabinet 4 was excluded on the grounds of cost. This raises concerns about BDUK's plan for cabinet 4 customers to receive 2Mb/s resulting from "general network improvements".

While there is some potential to involve commercial companies to provide better broadband independently of BDUK and BT, the main issue with these solutions continues to be the cost of implementation and the difficulty in them achieving a return on investment that makes it worthwhile. One of the most effective solutions would also be likely to result in local people losing the internet completely for a couple of weeks while that solution is implemented, and there are clearly concerns as to whether people would be prepared to put up with that in order to benefit from faster broadband.

I do have some further ideas on how to progress local broadband, and how potential solutions could be funded. However, due to the proximity of the upcoming elections, I will investigate these solutions after the elections.

I submitted a representation to the Environment, Food and Rural Affairs (EFRA) Committee when it considered rural broadband.

My submission lead to the following quote in their report issued on February 3rd 2015:

"Nearly every council and Local Enterprise Partnership for growth emphasises the importance of superfast broadband and other digital infrastructure in attracting and retaining businesses of all sizes. Councillor Tom Howard suggested that broadband was a core service requirement for rural living, while the Local Government Association added that:

Access to fast and reliable broadband is as important a strategic consideration as electricity, planning, housing and transport for living and doing business in the twenty-first century"

CO12 5JX Furthermore, the chair of the committee Miss McIntosh said: "The Universal Service Commitment of 2 Megabits per second (Mbps) is already outdated. This is a minimum speed commitment to the public and it must reflect modern technological demands, it is not high enough; 10 Mbps is a more suitable target. Further, it should be regularly reviewed to ensure the UK does not slip behind other European countries."

Street light funding

TDC included 160k in the budget for 2015/16 to pay Essex County Council to put the lights in Tendring back on between midnight and 5am.

This has been included to be used subject to the decision due at Full Council on 24th March 2015.

TDC are currently conducting a public consultation on whether TDC should pay Essex County Council to put their street lights back on between midnight and 5am.

Their consultation ends on 23rd February 2015.
