Layby

Cllr Steer mentioned that at the moment some cars that had been going to the football club had driven past the turnoff and were doing 3 point turns in the layby once they had realised they had missed the turn.

Cllr Howard told the council that he had been contacted by a parishioner who lived behind the bus stop opposite Seaview. The parishioner had told him that she believed that the bus shelter was on her land.

Cllr Jackson said that this had been brought before the council before quite a few years ago. The bus stop/shelter was in place before the houses were built.

The council has noted the Parishioners comments, but this was felt to be a County Council matter as they are in charge of highways.

15/059 Electricity quotes and contract

The clerk reported that she had got in touch with Eon and was told that if the Parish Council were to go onto a fixed contract then that would cost more as we would have to pay a standing charge. The clerk said that she mentioned the LED lights that the council had put in and Eon said that she should contact UK power Networks and let them know so that they could re calculate electricity consumption and inform Eon of the new consumption rate. They would then charge us accordingly.

The clerk said that she sent UK Power networks a list of the lights that had been changed over to LED and was now waiting for Eon and UK Power networks to get back as she cannot get any quotes until the energy consumption had been sorted out. The new consumption rate will be backdated to when the LED lights were installed (up to 12 months). This item will be put back on the agenda when the relevant details have been given to the clerk.

Cllr Jackson left the meeting at 20:15

15/00646/OUT - Land South East of Harwich Road Little Oakley Erection of 8 Dwellings

Cllr Griffiths declared a non pecuniary interest in this application as he lives opposite the proposed development.

The councillors looked at the plans and discussed this application Little Oakley Parish Council have always been in favour of small infilling. In the Local Plan, as Little Oakley is being classed as a smaller rural settlement, then that means a maximum of 10 houses will be allowed through the life of the Local Plan.

The Parish Council resolved to put in a neutral response at this point with concerns about flooding and the access visibility splays.

They will also ask for reserved matters to come back before the Parish Council, a new streetlight at the entrance of the proposed development (to be adopted by the Parish Council) as well as a donation to S106/CIL monies.

It was **resolved** that the clerk would draft a response and send it to Cllr Griffiths, Cllr Attrill and the chairman for approval before sending the response in. The response sent can be seen in appendix 1

Erection of 8 Dwellings - Land South East of Harwich Road Little Oakley Essex CO12 5JA

Little Oakley Parish Council would like to submit a **NEUTRAL** comment for this outline planning application.

Little Oakley Parish Council however do have the following concerns with this application:

- 1. Past flooding in the North corner of the field where the dwellings will be built
- 2. Insufficient visibility splays leading on to the highway

Little Oakley Parish Council would also like a streetlight to be placed at the entrance of the development, with the option to adopt the new streetlight if installed. The reason for this is because Little Oakley Parish Council are currently replacing Parish Council owned streetlights with LED lights and would like any additional streetlights to be in line with existing parish owned streetlights. I.e. same kind of style of LED and lights will not be turned off between the hours of 1am and 5am.

Little Oakley Parish Council would also like to request that S106/CIL monies be allocated to Little Oakley Parish Council from this development.
