Minutes of the Parish Council Meeting held on Wednesday 13th October 2021 In the Millennium Room, Ramsey Church, starting at 7.00pm

Present: Cllrs Attrill (Chairman), Griggs (Vice Chairman), Bush, Coates, and Hunnaball **Also Present:** County Cllr Land and Jeanette Sands (Clerk/RFO) **Members of the Public:** No members of the public attended the meeting.

21/88 Apologies for Absence

Apologies were received from Cllr Lane and accepted by all.

21/89 Declarations of Pecuniary and Non-Pecuniary Interests

No interests were declared.

21/90 Signing of the Minutes

The Minutes from the September meeting were accepted as a true record and duly signed.

21/91 Urgent Matters

It was noted that the damaged Oakridge sign has now been collected. The replacement may take up to two months.

21/92 Public Speaking

No members of the public attended.

21/93 Bus Shelter Maintenance

Agenda item 17 has been moved at the request of a Councillor. It was reported that the bus shelters require cleaning and vegetation growing around them trimming back. It was **RESOLVED** to contact Ashley Thomas to quote for adding these to the ground's maintenance. It was also **RESOLVED** to contact Ramsey Parish Council to enquire as to added their two shelters to the cleaning list and invoicing them pro rata.

21/94 Report from District Councillor Bush

District Cllr Bush reported that the A120 Horsley Cross to Ramsey roundabout closure would take four months and that this would cause damage to the village roads on the diversion routes.

The latest litter pick in Great Oakley was well supported and the next one in Little Oakley will be 7th November meeting at the recycling area at Little Oakley Memorial Club starting at 10.30.

21/95 Report from County Councillor Land

County Clir Land reported that the damaged drain cover on Mayes Lane has been reported along with the pothole on the B1414 near Hamford Tea Rooms entrance. C Clir Land had also visited the Montessori nursery at Two Village School as they are having problems with speeding and parking around the entrance. He had also looked at the possibility of a pavement on the corner of Mayes Lane before the mini roundabout but this may not be feasible and other options are being looked into. Finally, a resident had

enquired as to the possibility of having the VAS sign repaired, C Cllr Land will look into this.

21/96 Recreation Ground

Cllr Bush advised he is still chasing this up with Essex County Council (ECC) and County Cllr Land is also involved.

21/97 Remembrance Sunday

Ramsey Church have offered the services of one of their ministers for the service. The poppy wreath has already arrived and it is hoping the Tommy figure will be in place ready for November 14th. Cllr Hunnaball will open and close the service and will also read out the names of the fallen. It was **RESOLVED** to find a bugler for the service if possible.

21/101 Report from Working Groups
